## Accreditation Fee

Effective February 1, 2019 - June 30, 2020

Development of national public health department accreditation has involved, and is supported by, public health leaders and practitioners from national, Tribal, state, and local settings, as well as the Centers for Disease Control and Prevention and the Robert Wood Johnson Foundation. ### What the Fees Support

The accreditation fee supports the assessment of your VRHS unit against nationally adopted standards and measures and provides your VRHS unit with a full suite of ongoing accreditation services, including:

- An assigned PHAB Accreditation Specialist to guide your unit through the accreditation and reaccreditation process.
- Training of your VRHS unit's Accreditation Coordinator at the NAPHSIS conference, including access to training materials and expert trainers.
- Subscription to e-PHAB, PHAB's online accreditation system. This paperless accreditation information system makes the process easier and more cost-efficient for your unit to participate in accreditation.
- A Completeness Review of submitted documentation performed by PHAB staff prior to the site visit team's review and feedback, thereby ensuring that the documents reviewed by the site visitors are complete.
- A site visit, including a comprehensive review of your documentation against the national accreditation standards by a team of peer review experts.
- A site visit report with identified opportunities for improvements to help your unit better manage its activities and better serve your population.
- PHAB staff review of the VRHS unit's site visit report to ensure the report captures "who" the VRHS unit is, "what" they do, and "how" they do it, all against the conformity of the standards and measures. Also, a thoughtful and deliberative review of the site visit report by PHAB's Accreditation Committee.
- A communications support package that can be used to engage and educate stakeholders on your VRHS unit's journey to accreditation and ongoing culture of quality improvement.
- Annual quality improvement guidance and support through each accreditation cycle to help continue the QI culture advanced by accreditation.
- Support in preparation for reaccreditation.

### Fee Structure

The **Initial VRHS Accreditation Review Fee of \$16,350** is based on services provided by staff, peer reviewers and training, the subscription to e-PHAB, and the Accreditation Coordinator's training.

The **Annual Accreditation Services Fee of \$4,100** supports the ongoing process of the Vital Records/Health Statistics unit as it goes through the accreditation life cycle and is invoiced each year, beginning one year after the Initial VRHS Accreditation Review Fee invoice. The Annual Accreditation Services Fee also covers the reaccreditation process so that the VRHS unit does not need to concern itself with additional budget dollars at the time it is eligible for reaccreditation.

Both the Initial VRHS Accreditation Review Fee and the Annual Accreditation Services Fee are published in January each year and are good for the period July 1 of that year through June 30 the following year. Fees are subject to review for potential annual expense adjustments to take effect on July 1 of each year. Any changes to the fee amount will be announced in January of that same year.
